

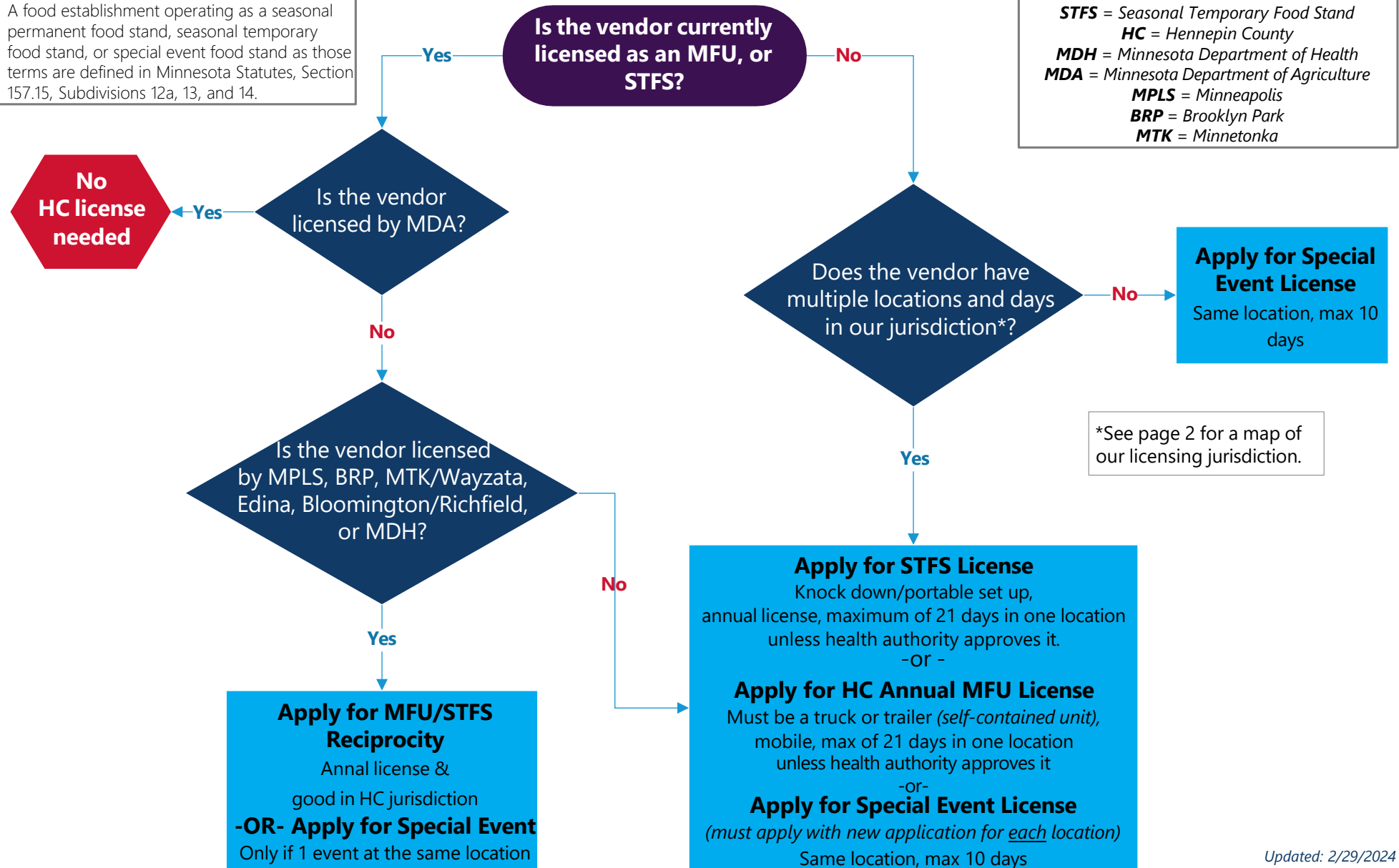

3.3 "Itinerant food establishment"

A food establishment operating as a seasonal permanent food stand, seasonal temporary food stand, or special event food stand as those terms are defined in Minnesota Statutes, Section 157.15, Subdivisions 12a, 13, and 14.

MFU = Mobile Food Unit
STFS = Seasonal Temporary Food Stand
HC = Hennepin County
MDH = Minnesota Department of Health
MDA = Minnesota Department of Agriculture
MPLS = Minneapolis
BRP = Brooklyn Park
MTK = Minnetonka



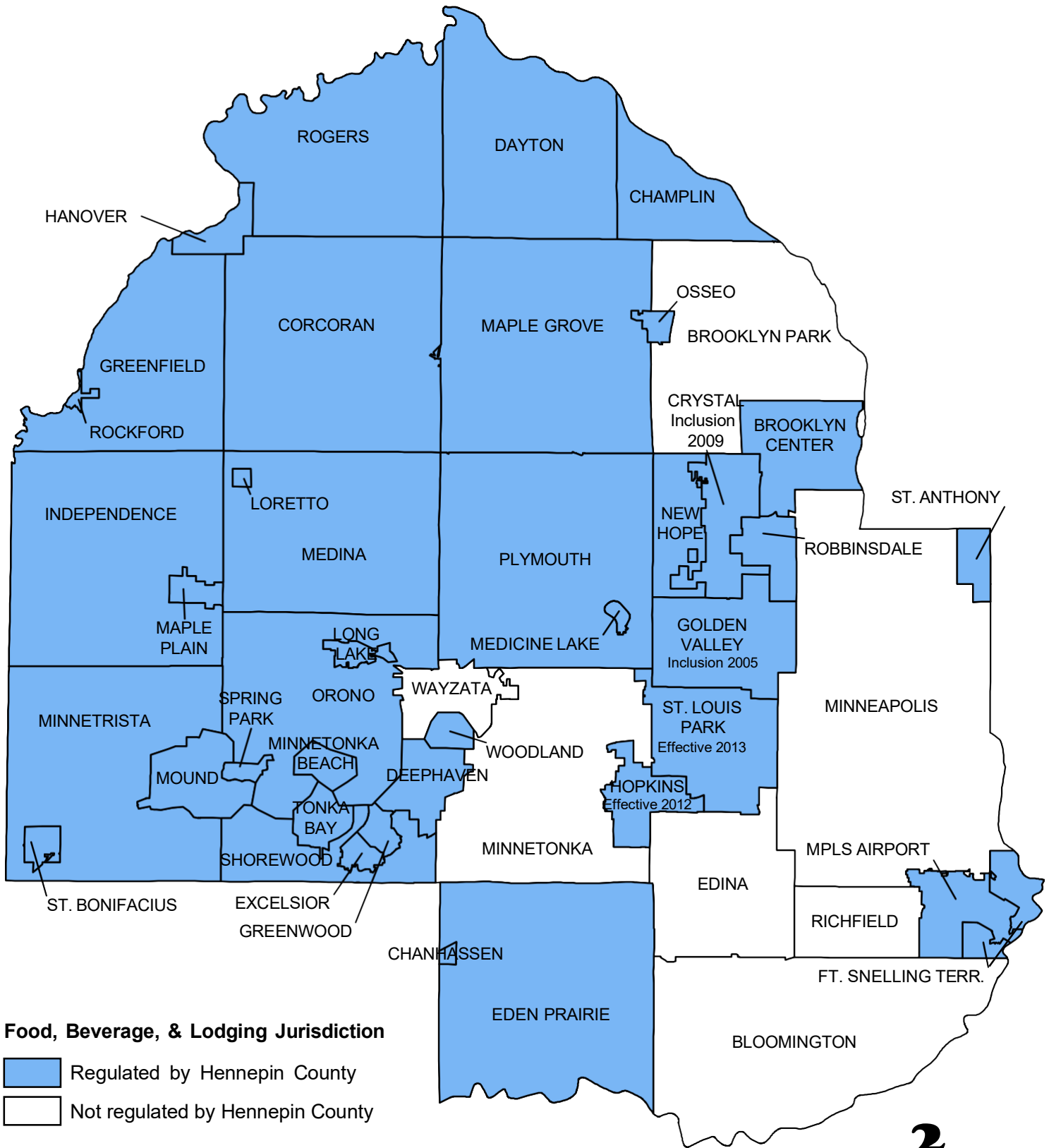

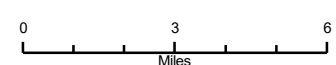

Applying for an Itinerant or Mobile Food License

How to apply:

Seasonal Temporary Food License valid April 1st to March 31st

Annual HC Mobile Food Unit License (currently unlicensed by another eligible jurisdiction) valid February 1st- January 31st

- Submit the completed application and all supporting documents for a new build or existing unlicensed mobile food unit

MFU/STFS Reciprocity License (currently licensed in another eligible jurisdiction) valid Feb. 1 – Jan. 31

- Submit the completed application and all supporting documents listed

Special Event License valid for approved date(s) and location (10 day max.)

- Applications received less than 2 business days prior to the event start date will not be processed. A sold-on-site license option will be available at double the original license fee if requested.

Options for submitting applications:

- **Submit the application by mailing** it to the address listed on the application along with a check or write in your credit card information on the application – if you want to pay by card over the phone, write that you'd like to do that somewhere on the application and someone will call you when the application is being reviewed in our office.
- **Submit the application in person at our office** located at 479 Prairie Center Drive, Eden Prairie, MN 55344. Business Hours are 8am-4:30 M-F. Please bring completed application, applicable support documents, and payment.
- **Submit the application via email** to: epi-envhlth@hennepin.us and either write on the application you want to pay via card over the phone or mail a check separately and make a note on the application that the check is in the mail. Applications will not be processed or reviewed until payment is received.
- **DO NOT EMAIL CREDIT CARD INFORMATION.**

**Note: All supporting documents such as blueprints must be sent in paper form. No electronic submissions of supporting documents.
