The Basics: Transmission-Based Precautions in the Long-Term Care Setting

Facilitator guide

Overview

This training is intended to provide basic transmission-based precautions education for long-term care frontline staff in an interactive format including demonstrations, activities, and discussion. Consider using for new employee orientation, annual inservice training, or in response to newly identified concerns in transmission-based precautions practices. It is designed to be easily accessible and facilitated by the facility's infection prevention leader(s). The facilitator may choose to play the recording or present the material themselves. The learning objectives for this training are as follows:

Upon completion of this training, participants should be able to:

- 1. Demonstrate proper technique for donning and doffing personal protective equipment (PPE)
- 2. Describe the different types of transmission-based precautions.
- 3. Determine what PPE is appropriate based on the type of transmission-based precautions in place.
- 4. Apply transmission-based precautions knowledge to long-term care situations.

Materials needed

- 1. Download the PowerPoint slide deck: The Basics: Transmission-Based Precautions in the Long-Term Care Setting
- 2. Platform to present slide deck with visual and audio (e.g., computer, laptop, speakers and/or projector)
- 3. Enough gloves, gowns, eye protection, for masks for training participants. You may consider having respirators available for those who have completed a medical evaluation and fit testing.
